### ADDENDUM

Apropos the notice in original No.IEL.IX/97/2021-22/02 dated Dated: 27<sup>th</sup> April 2021 for Request for Proposal (RfP) For "Hiring an Agency to provide Manpower Support to the State Designated Agency Meghalaya", this addendum hereby modifies the following under clause 10 of the RfP document by adding subsection 10.16 Exemption for MSEs and Startups and 10.17 Authorized representative for Technical and Financial Bid Opening which are as follows:

- **10.16 Exemption for MSEs and Startups:** The tenderers who are currently registered and shall continue to remain registered during the tender validity period with Central Purchase Organisation (CPO) or as a Micro and Small Enterprise (MSE) as defined in MSEs Order 2012 issued by Ministry of Micro, Small and Medium Enterprises (MSME) or as a Startup as recognised by Department for Promotion of Industry and Internal Trade (DPIIT), are exempted from payment of tender fee and earnest money. In case the tenderer falls in these categories, it should furnish certified copy of its valid registration details (registration with CPO or as a MSE or Startup, as the case may be).

Micro & Small Enterprises must attach Registration Certificate issued by DIC /KVIC / KVIB / Coir Board / NSIC / Directorate of Handicrafts and Handlooms, or any other body specified by MSME for authentication such as Udyog Aadhaar Memorandum / Acknowledgment.

- **10.17 Authorized representative for Technical and Financial Bid Opening:** Due to prevailing situation of COVID-19, the bidders needs to intimate the authorized representative who would be present during the meeting of technical and financial bid opening office via email at [msda-meg@gov.in](mailto:msda-meg@gov.in) on or before 13<sup>th</sup> of May 2021 so that the office may undertake necessary arrangements and maintained the Government SOP for the same. Also, the authorized representative needs to produce a COVID test certificate on the day of the meetings. The validity of the certificate should be within 48 hrs from the time of the meetings.

Non – Compliance of the above may lead to disqualification in attending both the meeting of technical and financial bid opening.
